ORDER

1. Kerala University of Health Sciences is conducting inspections for various purposes such as starting new college, courses and granting of continuation of provisional affiliation. During the inspection it was found that many colleges were failed to comply the norms fixed by University and Central Councils, This may lead to further inspections to that colleges.

2. In order to conduct re-inspections to the colleges, who failed to comply the norms fixed by University and Central Councils, the rate of fine to be levied for each re-inspection were fixed vide order read 1st above.

3. Recently the number of re-inspections increased due to the fact that the colleges fails to fulfill the major deficiencies such as IP strength, Faculty deficiency etc-. This practice adversely affects the credibility of the University. Moreover the inspectors are showing reluctance for these frequent inspections.

4. The matter was placed before the Governing Council for consideration and the 49th Governing Council meeting held on 08.11.2018 vide decision read 2nd above has decided to modify the norms fixed vide order read as 1st above for conducting re-inspections, as detailed below:

a. **For minor deficiencies** such as shortage of library books, minor equipments etc- **No re-inspection is required.** Affiliation shall be granted conditionally based on the compliance report submitted by the concerned college. This shall be verified in the next year's surprise inspection.

b). **For major deficiencies** such as faculty deficiencies, in patient strength etc-- **Re-inspection shall be conducted with a fine of Rs.20,000/- (Rupees twenty thousand only)** from the concerned colleges and on submission of an affidavit from the Principal to the effect that the college has rectified all the deficiencies noted by the inspection team and the findings of the Re-inspection conducted by the University to verify this claim shall be final.

c. **If the deficiencies are not rectified after the Re-inspection.** The Governing Council shall fix the quantum of penalty and such other penal actions on case to case basis.

5. Sanction has been accorded by Hon'ble Vice Chancellor to implement the decision of Governing Council.

6. The decision of the Governing Council is implemented and orders are issued accordingly.

7. The order read 1st above stands modified to the above extent.


