The 86th, 90th, 92nd and 94th meetings of Malpractices and Lapses Enquiry Committee considered these cases respectively and **have** decided to issue show- cause notices to the aforesaid Evaluators . **Further, the** explanations furnished by the Evaluators have been considered by the Malpractices and lapses Enquiry Committee. The committee opined that the explanation furnished by these evaluators is not satisfactory. Considering the difficulty in the functioning of the routine process in the exam sections thereby delaying the whole process, the Committee recommended to ***debar the aforesaid evaluators for one year from the exam related jobs of KUHS (as per the provisions in 1(B)1 (page 91) of examination Manual) and to inform this matter to the institution,***vide paper read as (1) to (4) above.

The 56th meeting of Governing Council held on 26.08.2019 has considered the matter and resolved to approve the recommendations of the Malpractices and Lapses Enquiry Committee,vide paper read as (5) above.

Vide reference (6) cited above, the Honourable Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the recommendations of the Malpractices and Lapses enquiry committee.
