- a) to cancel the entire examination of Third year Pharm D Degree (R/S) Exam June, 2019 and Final B Pharm Degree (R/S) Examination May, 2019 written by the candidates, Muhammed K and Shyma.S.A, respectively and to debar them from appearing for next University-examination
- b) to cancel all papers of II B Pharm (S) Examination, June 2019, written by the candidate, Anju Prasad and to debar her from appearing for next two chances of University examinations asper the provisions I A 16 (page number 90) in Examination Manual, considering the fact that she was punished earlier by the University for same malpractice (MLEC 85.4) as per UO third cited above.

Vide reference (4) cited above, the Honourable Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the recommendations of the Malpractices and Lapses Enquiry Committee.
