2.The BOS PG Pharmaceutical Sciences vide paper read (1) above suggested to continue with the Research Methodology & Biostatistics end semester examination (75 marks) as non University examination itself and to modify the Research work presentation (350 marks) to a University examination for which the external examiners may be posted from different zones of KUHS. The board decided to modify the examination pattern of M.Pharm 3<sup>rd</sup> semester in the following manner from 2019 admission onwards

**1. Internal assessment - 75 marks**

including • Proposal presentation - 25 marks

- Journal Club - 25 marks
- Research Methodology & Biostatistics - 25 marks

**2. End semester university examination - 425 marks**



including • Research Methodology & Biostatistics - 75 marks

• Research work presentation - 350 marks

**Total - 500 marks**

(i) The end semester theory examination of Research Methodology & Biostatistics shall be conducted by the University just like the conduct of any other theory examination of semester I or semester II.

Faculty members having M.Pharm in Pharmacology/ Pharmacy Practice with minimum 10 years of post PG teaching experience may be appointed as Question Paper setters.

Faculty members having M.Pharm in Pharmacology / Pharmacy Practice with 5 years of post PG teaching experience may be appointed as evaluators.

ii) At the end of the 3<sup>rd</sup> semester, along with the theory examination of Research Methodology & Biostatistics the research work presentation shall be conducted, which shall be evaluated by the qualified PG examiners of the speciality concerned. The examiners shall be appointed on a zonal basis from different institutions of KUHS.

The research work presentation shall be evaluated in the following manner.

- Content of the work & its progress - 200 marks
- Presentation including slide preparation - 100 marks
- Viva Voce ( defence ) - 50 marks

**Total - 350 marks**

3.The meeting of Board of Studies PG Pharmaceutical Sciences dated 15.05.2019 was approved by the Faculty of Pharmaceutical Sciences held on 15.05.2019 vide paper read(2) above.

4.The Academic Council accepted the proposal to conduct the end Semester examination of M.Pharm third semester for 425 marks as University examination from 2019 admission onwards vide paper read (3) above.
