<u>ORDER</u>

In accordence with the GC decision no 59.45, University vide paper read (1) above constituted a GC subcommittee comprising Dr.Satheesan Balasubramanian,Dr.Fazal Gafoor,and Mr.Prakasan as members to frame norms for granting Continuation of Provisional Affiliation to MLT colleges. The committee held its meeting on 01.05.2020 via video conferencing and submitted its report. University accepted the report and decided to implement the norms for faculty requirement for BSc MLT courses recommended by the GC subcommittee, subject to ratification by the Governing Council.

2. Hence the norms for faculty requirement for conducting BSc MLT courses for the academic year 2020-21 shall be as follows.

i. Colleges having 4 batches of BSc MLT course on the ensuing academic year .

 (a) College should have at least one Professor and two Associate Professor/ faculty with 7 years post PG teaching experience and total number of faculty as per norms. Among the three senior faculties
(professors/Associate Professors) one each shall have specialization in subjects Biochemistry, Microbiology and pathology.

(b) However if the college is having the first batch of 4th year classes, college should have the total number of faculty required for 1st, 2nd and 3rd Year and shall appoint the required number of faculty for the 4th year before the commencement of classes for the ensuing academic year and an undertaking for the appointment of such faculty shall be furnished. If the college is not having the required number of professors and Associate professors, then such institutions shall furnish an undertaking to appoint at least one Professor and two Associate Professor/ faculty with 7 years post PG teaching experience and total number of faculty as per norms. Among the three senior faculties (professors/Associate Professors) one each shall have specialization in subjects Biochemistry, Microbiology and pathology. The details of newly appointed teachers shall be submitted to KUHS before 30<sup>th</sup> September 2020.

ii. Colleges having the first batch of 3rd year classes in the ensuing academic year,

a)College should have total number of faculty for the 1st and 2nd year. The college shall appoint the required number of faculty for the 3rd year classes before the commencement of the ensuing Academic year.

b)If the college is not having the required number of professors and Associate professors, then such institution shall furnish an undertaking to appoint at least three Associate Professor/ faculty with 7 years post PG teaching experience and total number of faculty as per norms. Among the three senior faculties (Associate Professors/faculty with 7 years post PG teaching experience, one each shall have specialization in subjects Biochemistry, Microbiology and pathology. The details of newly appointed teachers shall be submitted to KUHS before 30<sup>th</sup> September 2020.

iii. Colleges having 1st batch of 2nd year classes in the ensuing academic year,

(a) College should have the total number of faculty for the 1st year. The college shall appoint the required number of faculty for the 2nd year classes before the commencement of the ensuing academic year.

(b) An undertaking for the appointment of such faculty shall be furnished and the details of newly appointed teachers shall be submitted to KUHS before 30th September 2020.

iv. If the Principal of the college is eligible as faculty of B.Sc MLT, course, he/she also be counted as faculty while calculating the total number of faculty.

v. If the Paramedical institution is attached to a medical college, then the medical faculty of those institutions shall be considered as faculty of the paramedical institution also. If so the name and other details of such medical faculties who are supposed to engage in MLT teaching shall be furnished to the university and their names shall be enrolled in the faculty enrolment register of MLT. A declaration shall be submitted by these teachers stating that they are engaged in the teaching programmes of MLT in the respective institution and they are ready to take part in examination duties including practical and theory evaluation.

3. The relaxation of norms suggested above is only for the academic year 2020-21.
