In the case of the candidate Mr.Sanjeed M P (Reg No120010276),as his ENT answer book (QP Code:302001) was not received in the University from the college the examination process could not be completed. Hence the 64^{th} Governing Council has decided the following.

- i. The result of the subject of Ophthalmology (QP Code:301001) of the above said candidate has to be declared.
- ii. If the candidate fails in this subject, the Third Professional MBBS Degree Part I Examinations January 2021 in toto should be cancelled and permitted to register for the upcoming Third Professional MBBS Degree Part I Examinations in both these subjects without remitting any fees.
- iii. The partially completed Third Professional MBBS Degree Part I Examination January 2021 will not be counted as a chance.
- 3. The decision was implemented vide UO read (2) above.
- 4. The result of the above said candidate was declared and the candidate failed in Ophthalmology (QP Code:301001) in the said examination.
- 5. Considering the above, Hon'ble Vice Chancellor has accorded sanction to cancel the Third Professional MBBS Degree Part I Examination January 2021 of the candidate and permitted to register for the Third Professional MBBS

Degree Part I Examinations May 2021 without remitting any fees. Furthermore, the cancelled Third Professional MBBS D egree Part I Examinations January 2021 will not be counted as a chance
