#### <u>ORDER</u>

The remuneration for the question paper setting Multiple Choice Questions (MCQs) of the Super specialty / M.Phil/ Ph.D courses and for the proof reading/Scrutiny of Multiple Choice Questions has been fixed as Rs.50 per question vide paper read (1) above. But the remuneration for the Setting of Multiple Choice Questions for the UG/PG Examinations has not yet been fixed.

As per the New Syllabus and Regulations of BAMS, BSMS, BUMS courses, the Question Paper pattern includes 20 MCQs each in each paper. Besides this, as per the New B.Sc Nursing Syllabus 6 MCQs are to be included in the question papers.

The 36<sup>th</sup> meeting of BoE held on 13.07.2023 recommended the rate of Rs.50/- per MCQ for UG/PG Examinations notified with effect from 01/04/2023 vide paper read as (2) above.

The 61<sup>st</sup> meeting of Finance Committee held on 13.07.2023 has considered and resolved to recommend the proposal vide paper read as (3) above.

The 75<sup>th</sup> meeting of Governing Council held on 29 /07/2023 approved the Proposal vide paper read as (4) above.

In the above circumstances, Hon'ble Vice Chancellor has accorded sanction to implement the decision of



the Governing Council with respect to remuneration for the Setting of Multiple Choice Questions for the UG/PG Examinations.
