ORDER

Ms. Aleena J Ancheril, (Reg No.170067275, BSc Nursing Course (2012 batch)) Institute of Nursing Education, SME Pala (N126) under MG University, availed Condonation of Break of Study and was permitted to continue her studies in Third year BSc Nursing course along with 2017 Batch under KUHS under 2016 Scheme on the condition that the student has to clear all the additional subjects, if any, under KUHS as stipulated in 2016 scheme found required by the Board of Studies of UG Nursing in due course for normalizing their marks in First year and Second year BSc Nursing secured under MG University.

The Board of Studies meeting of UG Nursing held on 03/11/2021 decided to normalize the marks of subjects passed by the student in 2010 scheme to 2016 scheme also decided to permit the student to appear for the failed subjects and subsequent years of examination of BSc Nursing under 2016 scheme.

Subsequently, the student appeared the failed subjects of first year(Microbiology) and second year(Medical Nursing & Surgical Nursing) BSc Nursing examination under the 2016 scheme and passed I BSc Supplementary Examination May 2022 and II BSc Supplementary Examination February 2022, respectively and passed all the subjects of III year BSc Nursing (January 2022) and IV year BSc Nursing(April 2023).

As such, Aleena J Ancheril completed BSc Nursing in the examination held in April, 2023 and passed all subjects, including the ones she had failed previously. But the status of the student is still remaining 'Failed', and only after entering the First and Second year marks of all Subjects including the marks she obtained in MG University, the Provisional Degree Certificate shall be generated and the status of the student become Passed.
