## **ORDER**

The rates of remuneration and Travelling Allowance to various exam related duties were fixed vide paper read as (1) above. A subcommittee of the Board of Examinations was constituted to revise the remuneration for various exams related duties, considering the persistent requests from the faculty appointed as the examiners and evaluators, vide paper read(2). The recommendations of the subcommittee were placed before the Board of Examinations for approval.

The 35<sup>th</sup> meeting of the BoE held on 07.02.2023 discussed the matter in detail and approved the proposal submitted by the subcommittee of BoE with the increased rates of remuneration for examination-related duties with modifications. The 35th meeting of the BOE also directed to include the remuneration rates for M.Phil thesis valuation at Rs.600/- per candidate per subject (subject to a minimum of Rs.3000/-) and recommended to place the proposal before the Finance Committee .

The 59th meeting of the Finance Committee held on 23/02/2023 vide paper read as (5) above, resolved to recommend the afore mentioned proposal for revising the remuneration for various exam related duties and the remuneration rates for M.Phil thesis valuation for subsequent placement before the Governing Council. The Finance Committee further recommended that , the revised rates may be

made effective for examinations notified on or after 01.04.2023.

The 73rd meeting of the Governing Council held on 25/02/2023 approved the recommendations of the Finance Committee vide paper read as (6) above.

In the above circumstances, Hon'ble Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the revision of remuneration, travelling allowance and halt allowance for various Examination related duties and the remuneration rates for M.Phil thesis valuation. The revised rates are effective for the Examinations notified on or after 01.04.2023.

The earlier orders in this regard stand modified and the revised rates are given in the Annexure.

Orders are issued accordingly.
