ORDER

Dr. Anna Daniel, (Principal ,NIPMR) the Chairperson of the CV camp of the First Year Bachelor of Occupational Therapy(BOT) Regular/Supplementary Examinations, December 2022 (2020 Scheme) and Second Year Bachelor of Occupational Therapy Regular Examinations (2020 Admission), November 2022 requested to give relaxation for the teaching experience criteria of Examiners/Evaluators of all examinations of Bachelor of Occupational Therapy (BOT) as it is a newly started course and there is acute shortage of faculty with three years teaching experience. The Qualification/Experience criteria for the Examiners/Evaluators are not stipulated in the syllabus or Regulation of the Bachelor of Occupational Therapy (BOT) course.

The Dean, Allied Health Sciences also put his remarks in favour of the relaxation and suggested to place the matter before the BOE. Considering the matter in detail, the Hon'ble Vice Chancellor, has ordered that ***the teachers with one year teaching experience can be appointed as examiners/evaluators for all examinations of Bachelor of Occupational Therapy (BOT) for the succeeding three academic years from above examination subject to the ratification by BOE.***

The 35th meeting of BoE held on 07/02/2023, has considered the matter in detail and decided to ratify the action in having given relaxation for the teaching experience of Examiners/Evaluators of all examinations of Bachelor of Occupational Therapy (BOT).

The 73rd meeting of Governing Council held on 25.02.2023 vide Agenda No. 73.25 considered the above matter and resolved to approve the same, vide paper read as (2) above.

The Hon. Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the action in having given relaxation for the teaching experience of Examiners/Evaluators of all examinations of Bachelor of Occupational Therapy(BOT).
