ORDER

KUHS has introduced a new Evaluation System namely **Remote Digital Evaluation** as a part of introducing more digital mode of activities to its effective functioning. The term Remote Digital evaluation denotes digital evaluations conducted away from the University Head Quarter at approved Remote Digital Evaluation Centres (**RDEC**) established at various colleges affiliated to the University.

In Remote Digital Evaluation, valuation is being done by the faculties from the Remote Digital Evaluation Centres (**RDEC**) itself, ie. from the affiliated colleges. They are not eligible for TA/DA/Camp Allowance. If the college has no facilities for Remote Digital Evaluations, the valuation is being done at another college under the same management. They are also not eligible for TA/DA/Camp Allowance.

KUHS is providing a facility for Digital Evaluation at the University Head Quarters for those colleges which have not established Remote Digital Valuation Centres of their own. But the faculties who were engaged in Digital valuation at University Head quarters were also not eligible for TA/DA/Camp Allowance. Many requests for TA/DA/Camp Allowance have been received in University with respect to this.

The 35th meeting of BoE held on 07/02/2023, has considered the matter in detail and decided to continue the provision of TA and DA as per existing University rules, for evaluators engaged in Digital evaluations at the University Headquarters. Conducting Digital evaluation camps at the University head quarters has to be reviewed when the establishment of RDEC is completed in majority of the affiliated colleges. The BoE Further decided that no TA and DA will be provided for digital evaluations when conducted in the Remote Digital Evaluation mode and to forgo the provision of Camp allowance forthwith.

The 73rd meeting of Governing Council held on 25.02.2023 vide Agenda No.73.25 considered the above matter and resolved to approve the same, vide paper read as (2) above.



The Hon' ble Vice Chancellor has accorded sanction to implement the aforesaid decision of the Governing Council with respect to TA/DA for Remote Digital Evaluation

Orders are issued accordingly.
