## **ORDER**

The case with respect to the failure from the part of the College authorities to enter the practical marks of Thazlima N (Reg. No. 190140156, 2019-2023 BASLP, National Institute of Speech and Hearing (NISH), Thiruvananthapuram ) for the subjects "Child Language Disorders" and "Diagnostic Audiology" at Fourth Semester BASLP Supplementary Examination January 2023 was reported before 142nd meeting of Malpractices and Lapses Enquiry Committee (M&LEC).

The aforementioned student had appeared for the 4th semester BASLP Degree supplementary examination January 2023 for the subjects "Child Language Disorders" and "Diagnostic Audiology-Physiological Tests". As she could not appear for the regular examination held in January 2022 due to Covid – 19, the student had appeared subject practicum of the above mentioned subjects during the regular examination held on 7th & 8th of February 2022 and the marks of the practicum were submitted to the University at that time. Since, the marks were already submitted after the 4th semester regular examination, the college authorities failed to enter the practicum marks of the aforementioned student for the two theory subjects during the clinical practicum examination held on January 2023.

The 142nd meeting **of** M&LEC recommended to place the matter before the Board of Examinations for a decision. The 36<sup>th</sup> meeting of BoE held on 13/07/2023, has considered the matter and decided that, since the Practical Examination marks were not recorded, the student should attempt the next upcoming Practical Examination and the marks then scored be counted as the Practical marks of the January 2023 Supplementary Examination and the results be declared accordingly, vide paper read as (2) above.
