The 75th meeting of the Governing Council held on 29.07.2023 considered the above matter and resolved to approve the same, vide paper read as (5) above.

Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to granting permission to students with Type 1 Diabetes for keeping essential provisions such as insulin pump, insulin pen, sugar tablets, water, chocolate candy, Fruits ,snacks etc in the Examination hall during Examinations and Extra time for Examinations on a case to case basis depending upon the Disability Certificate produced.
