ORDER

Several complaints were received regarding the conduct of the evaluation of the single college conducting courses such that, deliberate efforts are being made to pass the examinations by way of third valuation conducted by the Internal Examiners of the same institution, as they are well aware of the fact that the third valuation is going on.

As per the detailed verification of the evaluation process of such colleges, it was revealed that pass marks and above have been awarded to all evaluations even for the students who had attained below 40 marks, and also reported the possibility for misuse of third valuation system, particularly in the cases of Single College Courses affiliated under KUHS where the first and second valuation are conducted by Internal and External examiners respectively, as stipulated in Course Regulations. But in the case of third valuation which is not mentioned in Regulations, is done by the Internal Examiners of that college realizing the fact that they are conducting third valuation. At the same time such intentional awarding of marks cannot be possible in multiple college courses.

The Enquiry Report on such incidents recommended that the third valuations of Single College conducting courses shall be done under the direct supervision of the university by appointing evaluators from other universities or colleges, in spite of the present system of evaluation by the Internal Examiners of the single college, as a remedial measure.

The 36th meeting of BoE held on 13/07/2023, has considered the aforesaid recommendation in the new Enquiry Report and recommended to conduct third valuations of examinations in such courses that are being conducted in single colleges under the direct supervision of the university by appointing evaluators from other colleges/ Universities, replacing the present system of evaluation by the Internal Examiners
