## ORDER

Vide paper read (1) above, order was issued to cancel the theory examination centre status of Rajiv Gandhi Institute of Pharmacy Kasargod by the Governing Council based on the recommendations of Malpractices and Lapses Enquiry Committee (M&LEC) and Board of Examinations.

Based on the Self Assessment Report submitted by the college claiming the rectification of deficiencies, a physical verification was conducted at the college on 14.02.2023, and the Assessor recommended that the overall facilities to conduct theory examination found satisfactory.

Vide papers read (3) and (4), sanction has been accorded by the Hon.Vice Chancellor to grant permission to reinstate the theory Examination Centre status of Rajiv Gandhi Institute of Pharmacy, Kasargod for the academic year 2023-24 provisionally, subject to the ratification of the Board of Examinations and Governing Council.

The 36<sup>th</sup> meeting of BoE held on 13/07/2023, has considered the matter with respect to reinstatement of theory examination centre status of Rajiv Gandhi Institute of Pharmacy Kasargod. The BoE, vide paper read (5) above, decided to ratify the action in having reinstated the theory examination centre status of Rajiv Gandhi Institute of Pharmacy Kasargod.
