### ORDER

The examination fee and other fee levied for various services rendered by the Examination Branch were fixed vide papers read as (1), (2) and (3) above. The matter of unifying the fees for similar services among various streams of the Examination branch and publishing the details of fee for all exam related services on the University Website was placed before 35<sup>th</sup> meeting of Board of Examinations for discussion.

The 35<sup>th</sup> meeting of BoE held on 07.02.2023 discussed the matter in detail and approved the matter with the following recommendations vide paper read as (4) above.

- To modify the fee for Examination Registration from per paper to "Per QP Code"
- To charge the fee of Rs.500/- for Mark list (Super Specialty) .
- To charge the fee of Rs.1050/- for mercy chance (per chance in addition to the normal examination fee) and Rs.1050/- for Thatkal service,
- To continue with the Fee of Rs.225/- per paper for re totaling and Rs.555/-per paper for photocopy of answer books .
- To modify the fee for theory exam centre change as Rs.110/- per candidate per paper.

The 73rd meeting of the Governing Council held on 25/02/2023 vide agenda No.73.25 approved the aforesaid recommendations of the BOE vide paper read as (5) above.



In the above circumstances, Hon'ble Vice Chancellor has accorded sanction to implement the aforementioned decision of the Governing Council with respect to Unification of exam related fees.

The earlier orders in this regard stand modified.

Orders are issued accordingly.
