## **ORDER**

The Chairperson of Third Professional MBBS Degree Part II Regular/Supplementary Practical Examinations March 2023 conducted at Sree Gokulam Medical College and Research Foundation, Thiruvananthapuram has reported that while uploading the practical marks for the paper 'Obstetrics & Gynaecology' (held on 20.04.2023) the marks in respect of the student Gouri Prasanth with Register Number 180012107 was wrongly entered as '13' instead of '30' in the University portal. The chairperson also reported that the lapse was noticed only after the publication of result.

- 2. The 146<sup>th</sup> meeting of the Malpractices and Lapses Enquiry Committee directed Dr. Suja Daniel, the Chairperson of Practical Examinations, to appear personally before the Controller of Examinations, along with the Internal and External Examiners for uploading the correct practical mark. The Committee also recommended to convene a Special Pass Board (Re-Pass Board) in this case and to place the decision before Board of Examinations for ratification. Based on the recommendation of M & LEC, the Chairperson and the Examiners presented in person before the Controller of Examinations on 03.07.2023 with necessary supporting documents and uploaded the correct mark of the candidate in the examination portal. Subsequently a Special Pass Board was convened on 07.07.2023 and the revised result has been published, based on the recommendation of the special Pass Board.
- 3. Vide paper read (1) above, the 37<sup>th</sup> meeting of BoE held on 14/12/2023 discussed the aforementioned matter and ratified the action in having published the revised result of the student Gouri Prasanth (Register Number 180012107) based on the recommendation of the Special Pass Board.
- 4. The 77<sup>th</sup> meeting of the Governing Council held on 21/12/2023 vide paper read as (2) above has considered the recommendations of BoE and resolved to approve the same.
