ORDER

As per National Medical Council PG regulations clause 14(1) sub clause (2), the maximum number of students to be examined in clinical/practical and oral on any day shall not exceed **eight** for MD/MS Degree/Diploma.

2. As per KUHS Syllabus, the maximum number of Students to be examined in clinical/practical and oral on any day shall not exceed Six for MD/MS Degree.

3.The Examination Committee decided that the number of candidates per day may be increased to seven as per the NMC guidelines based upon the discretion of the Controller of Examinations.

4. Considering the requests received from various colleges/Chairman of Practical Examinations/Conveners, the Controller of Examinations has granted permission to conduct the Practical Examination (Medical PG Degree R/S Examinations, July 2023) with **7** candidates per day subject to the ratification of the Board of Examinations.

5. The 37th meeting of BoE held on 14/12/2023, ratified the decision taken by the Controller of Examinations to increase the number of candidates per day for Medical PG Practical Examination from Six to Seven for Medical PG Degree/Diploma(Regular/supplementary) Examination July 2023. **The BoE decided to continue the number of candidates per day as seven for Medical PG Degree Practical Examination from the forthcoming PG Practical Examinations**, vide paper read as (1) above.

6. The 77th meeting of the Governing Council held on 21/12/2023 has considered the aforementioned recommendations of BoE and resolved to approve the same, vide paper read as (2) above.

7. The Hon'ble Vice Chancellor has accorded sanction to implement the decision of the Governing Council.
