ORDER

During the conduct of Third Professional MBBS Degree Part II Supplementary Examination, August 2023 with QP Codes 309001, 310001 and 311001 held at Govt. Medical College, Thiruvananthapuram, 52 page Answer booklets were distributed instead of 32 page Answer booklets.

2) The lapse was reported before the 150th meeting of the M&LEC and the invigilators and Chief Superintendent concerned of the aforementioned examination were called for.They explained that the answer booklets provided by the office staff were distributed among the students and the faculties only came to know that the distributed answer booklets were 52 pages instead of 32 pages during Mal Practices & Lapses Enquiry Committee (M&LEC) meeting and the faculties were apologized for the lapse occurred.

3) As the change of Answer booklets issued was a lapse from the part of Chief Superintendent and Invigilators in charge of the examination duty , 150th meeting of the M&LEC vide paper read as 1st above recommended to impose a fine on the concerned for the recovery of the loss that incurred to KUHS .

4) The 77th meeting of the Governing Council held on 21.12.2023 vide paper read as 2nd above has approved the above recommendations of the M&LEC and resolved to impose the cost of Answer Booklets amounting to **Rs.817/- (Eight hundred and seventeen rupees only)** on the Chief Superintendent and Invigilators concerned of the aforementioned examination.

5) In the light of the above, sanction has been accorded by the Hon'ble Vice Chancellor to implement the above decision of the Governing Council with respect to imposing a fine amounting to **Rs.817/-** on the Chief Superintendent and Invigilators concerned of the Third Professional MBBS Degree Part II Supplementary Examination, August 2023

with QP Codes 309001,310001and 311001 held at Govt. Medical College, Thiruvananthapuram.
