ORDER

The Board of Studies of Rehabilitation Sciences held on 12.09.2023 and the Faculty of Allied Health Sciences, at its meeting held on 11/12/2023 read as (1) & (2) above have recommended placing the matter of usage of calculators during the University examinations before the Board of Examinations.

- At present, simple calculators are permitted for certain examinations which need calculations and is specifically mentioned in the Question paper concerned.
- The 37th meeting of Board of Examinations held on 14/12/2023 vide paper read as (3) above discussed the matter with respect to usage of calculators. The Board of Examinations has recommended to permit Simple calculator only and Logarithm table shall not be permitted during the examinations. The Deans of each faculty shall provide Controller of Examinations with the list of Question papers in which the use of simple calculators have to be permitted and the same shall be mentioned in the question paper concerned.
- 4. The 77th meeting of the Governing Council held on 21/12/2023 vide paper read as (4) above has considered the aforesaid recommendations of the Board of Examinations and resolved to approve the same.
- 5. In the light of the above, sanction has been accorded by the Hon'ble Vice Chancellor to implement the above decision of the Governing Council with respect to the usage of simple Calculators during University examinations.
