ORDER

Remote digital evaluation facility has been extended to the faculty of Pharmaceutical Sciences and evaluations are being conducted successfully. Thirty nine (39) colleges have already been awarded provisional RDEC status vide paper read as (1) above. Considering the duly filled proforma submitted by Principals of four Pharmacy colleges (list annexed) to obtain RDEC status, inspections were conducted at these four Pharmacy colleges by the University.

- 2. On finding the facilities provided by the Colleges as satisfactory, sanction has been accorded by the Hon'ble Vice Chancellor to grant provisional Remote Digital Evaluation Centre (RDEC) status to these four affiliated Pharmacy Colleges (annexure I), subject to the ratification of the Board of Examinations . Along with this, sharing / common status has also been granted to 12 Pharmacy Colleges (annexure II) .
- 3. The 37th meeting of Board of Examinations held on 14/12/2023 vide paper read as (2) above considered the aforesaid matter and resolved to ratify the action in having granted Provisional Remote Digital Evaluation Centre (RDEC) status to Four Pharmacy Colleges and sharing / common status granted to 12 Pharmacy Colleges (annexed) for the digital evaluation .
- 4. The 77th meeting of the Governing Council held on 21/12/2023 vide paper read as (3) above resolved to approve the same.
- 5. The Hon'ble Vice Chancellor has accorded sanction to implement the above decision of the Governing Council with respect to ratifying the action in having granted Provisional Remote Digital Evaluation Centre (RDEC) status to Four Pharmacy Colleges and sharing / common status to 12 Pharmacy Colleges for the digital evaluation.
