## <u>ORDER</u>

As per paper read as (1) above , the Board of Examinations held on 14/12/2023 had considered the cases of shortage of Internal Examiners for different Examinations at colleges. The Board of Examinations recommended the following on detailed verification of each case ;

The BoE discussed the matter in detail and decided to impose fine as per the UO No.255/2018/Exam General dated 19/09/2018 upon SME Gandhinagar, since the college failed to provide internal Examiners.
2	Third year Bsc Nursing Degree Supplementary Examinations, October 2022	Institute of Nursing Research,MCC ,Thalassery	Mental health nursing and child health nursing.	As there is no pooling of faculties from Govt.colleges, MCC,Thalassery cannot be considered as a Government Institution. BoE discussed the matter in detail and decided to impose fine as per the UO No.255/2018/Exam General dated 19/09/2018 upon MCC,Thalassery since the college failed to provide faculty from the college itself.
3	Medical PG Degree/ Diploma Regular & Supplementary	Kannur Medical College,	MD Community Medicine	The Academic Section may be informed to recover the fine amount by other means like recovery from the Refundable Deposit of the
