#### **ORDER**

As per the University Order read (1) above, Kerala University of Health Sciences enhanced the existing fee for affiliation related matters and various academic services by 5% from the Financial Year 2020-21 onwards. Vide University Orders read (2), (3) and (4), additional fees are imposed for the services which were not mentioned in the University Order read (1) above. Further revision was put on hold in subsequent years in view of the covid pandemics.

As per the Section 25 (1) (xxii) of KUHS ACT 2010, the Academic Council is empowered to make proposals to the Governing Council to prescribe fees and other Charges. Now that four years have passed after the last revision, the matter of enhancement of the existing fee for various services like affiliation, continuation of affiliation, certificates etc. provided by academic branch was placed before the 37<sup>th</sup>

Meeting of the Academic Council and the Academic Council, vide paper read (5) above, recommended to revise all the fees levied for various services & certificates provided by the Academic Branch by 5 %

enhancement of fees by 5% and recommended to impose the revised fees with effect from 1<sup>st</sup> September

(Five percentage). As per the paper read (6) above, the Governing Council approved the proposed

2024.

Accordingly, orders are issued enhancing all the existing fees levied for various services/certificates provided by the Academic Branch by 5 % (Five percentage) with effect from 1st September 2024 as appended.
