ORDER

National Commission for Indian Systems of Medicine (NCISM) has implemented new Regulations for BAMS course vide paper read (1) above.

2. Accordingly, Kerala University of Health Sciences has drafted new Regulations for BAMS course (BAMS 2022) and made applicable from 2021 admission onwards (2021 Scheme). The same has been approved by the 70th meeting of the Governing Council held on 26.02.2022 and by the 12th meeting of Senate held on 04.03.2023. The Draft Regulations is yet to be gazette notified.

3. As per clause 1.14-Internal Assessment (Conducted by College) of the said Regulations, there shall be minimum three periodical assessments of similar marks for each subject. The best two among these three scores will be taken and the average shall be considered for determining the internal assessment. A minimum of 35% is required for appearing in university examination. The internal assessment marks will be considered as part of practical in the examinations during the time of result processing.

4. In accordance with the above said criteria for internal assessment, a minimum of "5.25 marks "" is required in the subjects Samskritam evam Ayurved Ithihas (Paper I) and Samhita Adhyayan - 1 "(i.e, 35% of the total marks (15 marks) as per NCISM/KUHS Regulations).

5. Considering the recommendations of the Dean, Faculty of Ayurveda, Siddha and Unani , it was decided to round off the internal minimum marks as 5 in the subjects Samskritam evam Ayurved Ithihas (Paper I) and Samhita Adhyayan - 1 for 2021 Scheme, subject to ratification by Board of Examinations.

8. The 77th meeting of the Governing Council held on 21/12/2023 has resolved to approve the same, vide paper read as (4) above.

In the light of the above, the Hon'ble Vice Chancellor has accorded sanction to implement the above decision of the Governing Council with respect to ratifying the decision to round off the minimum Internal marks to 5 for BAMS 2021 Scheme in the First Professional BAMS Degree (2021 Scheme) Regular Examinations July 2023 in the subjects Samskritam evam Ayurved Ithihas (Paper I) and Samhita Adhyayan – 1.
