3) The Hon'ble Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the recommendations of the Standing Committee of Board of Examinations.

4) The respective Sections in the Examination branch should serve demand notices to the colleges concerned in accordance with the above decisions.

5) All Sections are directed to impose fine upon Colleges which failed to provide adequate number of internal examiners/ Evaluators during the time of Examination Registration itself. If the College has any explanation for fee exemption, then only the matter may be placed before the Board of examinations/ Standing Committee of the BoE, for considering the cases of shortage of internal Examiners.
