ORDER

As per the Regulations of NCISM/KUHS for UG(BAMS) course, duration of the course is five and half years and the student will be awarded the degree only after passing all the four professional examinations and successful completion of one-year compulsory internship.

2. Consolidated Mark List/Academic Official Transcript/Consolidated Statement of Marks (Transcript of Marks only) are typically issued to students who have successfully completed their course, as these are often required for higher studies or job opportunities where course completion is mandatory. However, since this requirement is not specified in the respective Course Regulations, some students request the issuance of these documents before the successful completion of one-year compulsory internship.

3. Consequently, to fix the eligibility criteria and avoid perplexity in issuing the Consolidated Mark List/Academic Official Transcript/Consolidated Statement of Marks (Transcript of Marks only) for BAMS students , the 40th meeting of Board of Examinations vide paper read as 2nd as above has recommended to issue the Consolidated Mark List/Academic Official Transcript/Consolidated Statement of Marks (Transcript of marks only) to students, only after successful completion of course period including the Internship (if any).

4. The 82nd meeting of the Governing Council vide paper read as 3rd above has considered the above recommendations of the Board of Examinations and resolved to approve the same. In light of the above, the Hon'ble Vice Chancellor has accorded sanction to implement the above recommendations of the Board of Examinations.
