KUHS – Exam General A – Waiving off the fine regarding shortage of Internal Examiner and approval of relaxation to the faculties appointed based on CCH/MSR Regulations - Decision No. 82.49 of the 82  $^{\rm nd}$  meeting of the Governing Council - Implemented - Orders issued.

#### **ORDER**

As per Clause 9 (24) (a) of the BHMS Regulations 2022, "No Internal Examiner/ External Examiner shall be appointed unless he has taken a M.D (Hom.) degree of a recognised University or an equivalent qualification in the particular subject as per recommendation of the Commission on teachers' eligibility, qualification and has had at least three years of teaching experience in the subject concerned in a college affiliated to a recognized University at a faculty position".

- 2. During the verification of the First Professional BHMS Degree (2022 Scheme) Regular Examinations, July 2024, it was observed that there was a shortage of Internal Examiners at Shree Vidyadhiraja Homoeopathic Medical College, Thiruvananthapuram, for the subjects of Human Anatomy, Human Physiology, and Biochemistry. Consequently, a fine of Rs. 2,00,000/- (Rupees Two Lakh only) has been imposed.
- 3. Accordingly, the college has submitted a letter from the National Commission for Homoeopathy, which stated that, as per sub-clause (a) of clause (24) of Regulation 9 of the National Commission for Homoeopathy (Homoeopathy Graduate Degree Course Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S.) Regulations, 2022), the Regulations regarding the appointment of External or Internal Examiners, Paper setters, or Moderators apply prospectively, not retrospectively. Therefore, the appointments of External or Internal examiners, Paper setters, or Moderators already approved by the University before the publication of the NCH Regulation (BHMS) 2022 will remain unaffected.
- 4. As per clause 12, Part VI of 1983 Regulation of Central Council of Homoeopathy, (i) No person other than the holder of a Diploma obtained after 4 years of study or a Degree in Homoeopathy or a person possessing qualification included in the Third Schedule (Qualification granted by Medical Institutions

outside India) shall be appointed as an Internal or External Examiner or Paper setter for the conduct of a professional examination for the B.H.M.S.(Degree) any course. Provided also that these regulations shall not be applicable on teaching faculty appointed on prescribed post before this notification.

- 5. By Considering the MSR 2013 read as 4<sup>th</sup> above Shree Vidyadhiraja Homoeopathic Medical College was given relaxation in Academic Regulation 2015, as the faculties of the college were appointed as per 1983 Regulation. Following the direction of the NCH and recommendation of the Dean Faculty of Homoeopathy, the Hon'ble Vice Chancellor has accorded sanction to waive off the fine of Rs.2,00,000/(Rupees Two Lakh only) imposed on Shree Vidyadhiraja Homoeopathic Medical College, Thiruvananthapuram , for not providing Internal Examiners . The college has been permitted to complete the examination registration, subject to ratification of the Board of Examinations.
- 6. The 40 <sup>th</sup> meeting of the Board of Examinations vide paper read 2<sup>nd</sup> as above has ratified the action of waiving off the fine imposed on Shree Vidyadhiraja Homoeopathic Medical College, Thiruvananthapuram and also recommended to grant relaxation to the faculties who have already been approved as External or Internal examiner or Paper Setter or Moderator by the University before the publication of NCH Regulations (BHMS) 2022, as directed by the National Commission for Homoeopathy.
- 7. The 82<sup>nd</sup> meeting of the Governing Council vide paper read as 3<sup>rd</sup> above considered the recommendations of the Board of Examinations and resolved to approve the same. The Hon'ble Vice Chancellor has accorded sanction to implement the above recommendations of the Board of Examinations.
- 8. Orders are issued accordingly.
