ORDER

In consonance with the amendments notified by the Indian Nursing Council vide paper read (1) above, the Board of Studies in UG & PG Nursing, in its meeting held on 24.10.2025 vide paper read (2) above, has approved the incorporation of the said amendments into the B.Sc. Nursing Regulations and Syllabus of Kerala University of Health Sciences (KUHS) — 2021 Scheme. As the matter pertains to the academic progression of students and requires urgent implementation, sanction of the Hon'ble Vice-Chancellor has been obtained to give effect to the decision forthwith, subject to ratification by the Academic Council.

- 2. Accordingly, the following clauses are hereby modified in the respective regulations of the B.Sc. Nursing Programme (2021 Scheme):
- Regulation 3.4 (i) B.Sc (N) Course Regulations, 2021 Scheme Existing Provision: The candidate shall have cleared all the previous University examinations before appearing for University examinations at the end of fifth semester and before appearing for University examinations at the end of Seventh semester. However, the candidates shall be permitted to attend the consecutive semesters. Modified Provision (as per INC): The candidate shall have cleared all the previous examinations before appearing for seventh semester examination. However, the candidates shall be permitted to attend the consecutive semesters.
- Regulation 3.4 (ii) B.Sc (N) Course Regulations, 2021 Scheme Existing Provision: The candidate should clear all the previous examinations before appearing for final Semester / (Eighth Semester) examination. Modified Provision (as per INC): The candidate shall have cleared all the previous examinations before appearing for final Semester / (Eighth Semester) examination. (No change required – already aligned)
- Regulation 3.4 (iii) B.Sc (N) Course Regulations, 2021 Scheme Existing Provision: The maximum period

to complete the course successfully should not exceed 8 years. **Modified Provision (as per INC):** (No change required – already aligned)

- Clause 1.18 (c) B.Sc (N) Course Regulations, 2021 Scheme Existing Provision: The candidate should clear all the previous University examinations before appearing for university examinations in Fifth Semester and Seventh Semester. **Modified Provision:** "The candidate shall have cleared all the previous examinations before appearing for seventh semester examination."
- **3.** The reference to fifth semester clearance condition is hereby deleted from all relevant clauses, in line with the INC amendment.
- **4.** The KUHS B.Sc. Nursing Course Regulations and Syllabus read vide papers (3) & (4) above stand modified to the above extent with immediate effect.
