ORDER

1. As per the University Order read as 1st above, various Board of Studies of the University were constituted for a period of three years with effect from 20.06.2018. As per the Section 39 (9) of the Kerala University of Health Sciences Act 2010, if the person nominated, elected, appointed or Co-opted to an authority or body remains absent without prior permission of the authority or body for three consecutive meetings, he shall be deemed to have vacated his membership and he shall cease to be a member from the date of third such meeting in which he has remained absent. Also some of the members of Board of Studies have submitted their resignation.
