Sub : KUHS-Academic-Decisions taken by Various Academic Bodies-Intimation -reg:- Ref $\,:$ (1) Circular No 9552/2018/AC1/Med/B1/KUHS dtd 17/01/2020

BoS of Preclinical UG on 24/09/2019 vide decision 3.5.1 and Faculty on 15/11/2019 vide decision 3.4.1 have decided that the Logbook can be included in summative assessment with 20 marks and 80 marks for Viva .

2. BoS of Preclinical UG on 24/09/2019 vide decision 3.5.2 and Faculty on 15/11/2019 vide decision 3.4.1 have decided that Supplementary Exam will be conducted preferably with one month of publication of results. Those who fail in Supplementary Examination will join junior batch and should have 80% attendance for next exam from date of joining

3. The 24th meeting of the Academic Council held on 05/03/2020, vide decision 24.03 has approved the the above decisions of the Board of Studies and decided to inform the Principals and first MBBS students of all affiliated Medical Colleges that the University practical examinations will be conducted before theory examination and to direct the colleges to conduct model examination in the same pattern. The 59th meeting of the Governing council has approved the minutes of the 24th meeting of the Academic Council.

4. Vide paper read (1) above University issued a circular regarding the implementation of new MBBS curriculum and split up of internal marks. The combined meeting of BoS UG Clinical and Preclinical held on 27/02/2020 vide decision 3.8.6 decided to modify the eligibility criteria and split up of attendance and professionalism as detailed below

(a) Eligibility criteria: Learners must secure at least 50% marks of the total marks (combined in theory and practical/clinical, not less than 40% marks in theory and practicals separately) and atleast 50% in professionalism in a particular subject in order to be eligible for appearing at the final University examination of the subject. The three components are to be uploaded separately.

(b) Split up of Professionalism–20 Marks

Attendance – 6 marks, Seminar presentation –3 marks, Seminar attended –1 mark, Regular submission of records – 2 marks,Regular submission of logbook–2 marks, regular appearance in examinations–2 marks, Research activities – 2 marks, Extracurricular activities – 2 marks (Participation in University level/Prize at college level)

(c) Split up of Attendance:-

75 % to Less than 80% – 1 marks

80 % to Less than 85% – 2 marks

85 % to Less than 90% – 3 marks 90 % to Less than 95% – 4 marks 95% to 100% – 6 marks

The Hon'ble Vice Chancellor has accorded sanction to implement the above decision of the combined meeting of BoS UG Clinical and Preclinical held on 27/02/2020 subject to ratification by the Faculty, Academic Council and Governing Council.

5. In the circumstances the above decisions are implemented and the circular read (1) above is thus modified to the above extend.

6. All the Principals of Affiliated Medical colleges shall comply with the above decisions scrupulously.
