## <u>ORDER</u>

The decision of Board of Studies PG Pharmaceutical Sciences to Conduct University examination for the subject Research Methodology & Biostatistics in M.Pharm 3rd Semester for 425 marks out of 500 is implemented vide read(1) above.The clause 2(i) of U.O read(1) above stipulates the qualification for Question Paper setters and evaluators for the conduct of such examinations as follows

"The end semester theory examination of Research Methodology & Biostatistics shall be conducted by the University just like the conduct of any other theory examination of semester I or semester II.Faculty members having M.Pharm in Pharmacology/ Pharmacy Practice with minimum 10 years of post PG teaching experience may be appointed as Question Paper setters.Faculty members having M.Pharm in Pharmacology / Pharmacy Practice with 5 years of post PG teaching experience may be appointed as evaluators."

2. BoS vide read(2) above decided to modify the clause 2(i) as "Faculty members having M.Pharm and 10 years of post PG teaching experience may be appointed as Question Paper setters. Faculty members having M.Pharm and 5 years of post PG teaching experience may be appointed as evaluators for the subject Research Methodology & Biostatistics." Other conditions in the University order remains unaltered.

3.The minutes of the meeting of Board of Studies PG Pharmaceutical Sciences dated 14.10.2019 was approved by the Faculty of Pharmaceutical Sciences dated 14.10.2019 vide paper read(3) above.The minutes of the meeting of Board of Studies PG Pharmaceutical Sciences and Faculty of Pharmaceutical Sciences dated 14.10.2019 was approved by the 23rd meeting of the Academic Council held on 17.10.2019 vide paper read(4) above.

4. The meeting of Governing Council held on 23.12.2019 vide paper read (5) above resolved to approve the minutes of the meeting of the 23rd Academic Council held on 17.10.2019. The decision of Governing Council in approving the minutes of 23rd Academic Council was implemented vide order read(6) above.

5. In the circumstances clause 2(i) in UO read(1) above is modified as below

" The end semester theory examination of Research Methodology & Biostatistics shall be conducted by the University just like the conduct of any other theory examination of semester I or semester II. Faculty members having M.Pharm and 10 years of post PG teaching experience is eligible to be appointed as Question Paper setters. Faculty members having M.Pharm and 5 years of post PG teaching experience is eligible to be appointed as evaluators for the subject Research Methodology & Biostatistics".
