ORDER

The NMC has recently introduced a new form of supplementary examination for the first year MBBS students who failed to pass their University examinations. These candidates would get another chance to appear a similar examination immediately after the results of the regular examination are published and the students who are successful in this type of supplementary examination could join the same original (regular) batch without losing 6 months. These students would however forego the initial classes, which would have already started for the 'regular' batch. Students preparing for the supplementary examination do not attend 2nd MBBS classes or postings for obvious reasons. Loss of classes and postings caused by this absence has to be compensated.

The Combined BoS of UG Clinical and Preclinical held on 03-09-2021 has discussed the above matter in detail and the following decisions were taken about the attendance of students who have passed the First Professional MBBS Supplementary Examination and join the same original (regular) batch.

- All missed classes of such candidates have to be compensated. This should be done by holding extra classes and extra postings.
- This would help students passing the supplementary examinations and to merge seamlessly with their original batch. This could be done as follows,
 - a. First find out the number of hours/classes/postings lost. Compensate **all** the missed classes fully **by taking extra classes and extra postings outside conventional hours. Attendance for these students would be calculated taking into consideration of the extra classes also.** Then calculate the attendance as usual.
 - b. If for any reason, all the missed classes/postings could not be offered, attendance of the student would be calculated as follows,
- The reason why the remainder of the classes could not be taken/offered and to intimate that to the University.
- Percentage of attendance would be calculated on the classes attended by the candidate divided by the

actual number of classes offered to such students.(This may be followed while calculating the percentage of attendance for assessing the eligibility to appear for the University examinations of the subjects in question, *In an unfortunate situation where the classes/postings could not be fully compensated*).

(2) The minutes of the combined BoS of UG Clinical and Preclinical has not placed before the Faculty of Medicine.The said decision of the BoS needs urgent implementation for calculating the attendance of students who have passed the First Professional MBBS Supplementary Examination and join the same original (regular) batch.

(3) Considering the urgency, sanction is accorded to implement the decision of the combined BoS held on 03-09-2021 regarding the attendance of students who have passed the First Professional MBBS Supplementary Examination and join the same original (regular) batch subject to ratification of Faculty of Medicine, Academic Council and Governing Council.

(4) Orders are issued accordingly.

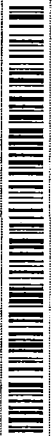
