**ORDER**

The 29<sup>th</sup> Governing Council meeting held on 21.12.2015 vide item No. 29.11 has decided to constitute a committee for preparing a detailed and realistic fee structure in comparison with other Universities. Accordingly, a six member committee was constituted vide University order read as 3<sup>rd</sup> above.

The meeting of the committee constituted for preparing a detailed and realistic fee structure held on 08.08.2017, after taking into consideration the fact that the application for continuation of provisional affiliation for the year 2018-19 is to be invited within stipulated period and the preparation of revised fee structure may consume time, recommended to continue the fee for continuation of provisional affiliation payable by affiliated Government / Aided and Self financing colleges in respect of UG/PG/Super Speciality courses for the year 2017-18 in the year 2018-19 also.

The recommendation of the committee was placed before the Governing Council for consideration and the Governing Council in its 41<sup>st</sup> meeting held on 25.08.2017, vide decision read 5<sup>th</sup> above, has decided to extend the time schedule for inviting notification for application for continuation of provisional affiliation for the year 2018-19 and to keep the fee structure for continuation of provisional affiliation for the year 2017-18 in the year 2018-19 also.

Sanction has been accorded by the Hon'ble Vice Chancellor to implement the above said decision of Governing Council and to keep the fee for continuation of provisional affiliation payable by affiliated Government / Aided and Self financing colleges in respect of UG/PG/Super Speciality courses for the year 2017-18 in the year 2018-19 also.


The decision of the Governing Council in fixing the fee for continuation of provisional affiliation for the year 2018-19 is thus implemented and orders are issued accordingly.
