ORDER

The 8th meeting of the Academic Council held on 29/12/2014 vide decision No: 8.09 has proposed the following norms for recognition of courses of other State and Central Universities and to grant equivalency certificate.

All regular degrees of Universities or deemed Universities enacted by an act of State Legislative Assembly or Parliament/section 3 of UGC Act 1953 can be equated with the degree of this University provided that;

- Regular degrees of the universities or deemed universities approved by the concerned statutory councils (MCI/DCI/PCI/INC/AICTE/CCIM/CCH) where there is an apex statutory council.
- Those courses/programmes must be of the same duration of the course/programme of this university.
- Must be of the same nomenclature in the same discipline.
- Eligibility for admission for programme under consideration must be same that of the eligibility criteria for admission of the programme with which it is equated.
- Minimum marks/grades required for a pass of the programme under consideration must be same as or above the minimum marks required for the pass of the programme with which it is equated.
- The programme under consideration for equating must contain at least 60% of the core (main) course content (syllabus/curriculum) of the programme with which it is to be equated. This has to be verified with the Chairman, Board of Studies concerned.

• The Equivalency certificate must be issued for both employment/higher education purpose.

The $23^{\rm rd}$ meeting of the Governing Council dated 11/3/2015 vide decision No: 23.08 and $24^{\rm th}$ meeting of the Governing Council dated 30/3/2015 vide decision No: 24.10(ii) has approved the norms proposed by the $8^{\rm th}$ meeting of the Academic Council.

Sanction is accorded by the Vice Chancellor for implementing the decision of the Governing Council vide paper read (2) and (3) above, superseding all the existing orders, to approve the norms for equalizing the courses of other state and central universities for granting equivalency certificate.

Orders are issued accordingly.
