**ORDER**

1. Kerala University of Health Sciences is conducting inspection for various purposes such as starting new college, courses and granting of continuation of provisional affiliation. For this purpose University has to pay TA/DA and inspection fee to the inspectors. As per the order above, a sum of 10,000/- has been fixed as a levy from the colleges for conducting the re-inspection /subsequent inspection.

2. During inspections for granting affiliation/continuation of affiliation for the colleges affiliated to Kerala University of Health Sciences, it was observed that many colleges are failing to comply with the University /Statutory Council norms, including that of infrastructure, clinical material, faculty, Library/Laboratory facilities etc-.This creates additional work load to the concerned sections. Even for the first inspection, University is facing difficulty in posting inspectors, let alone for the re inspection.

3. The matter was placed before the Governing Council for consideration and the Governing Council meeting held on 01.09.2018 vide decision read 2<sup>nd</sup> above has decided the following norms for conducting re-inspections, as detailed below:-

- a. **For minor deficiencies-** No re-inspection required. Affiliation shall be granted conditionally based on the compliance report submitted concerned college. This shall be verified in the next year surprise nature inspection.

- b. **For Major deficiencies-** Re-inspection shall be conducted with a fine of **Rs. 20,000/-**(Rupees twenty thousand only) from the concerned colleges.
- c. **Deficiencies were not rectified after 1<sup>st</sup> Re-inspection-** If the scrutiny committee recommends 2<sup>nd</sup> Re-inspection, a fine of **Rs.30,000/-**(Rupees thirty thousand only)- shall be levied from the concerned colleges.
- d. **Deficiencies were not rectified after the 2<sup>nd</sup> Re-inspection-** The Governing Council shall fix the quantum of penalty and such other penal actions on case to case basis.

The decision of the Governing Council is implemented and orders are issued accordingly.


