ORDER

1.As per the order read (2) above, Kerala University of Health Sciences enhanced the existing fee for affiliation and allied matters by 5% from the year 2019-20 onwards with the approval of Governing Council in consonance with the Govt. order read lst above. Wherein the rate of fee for Registration ,certificate verification, ID card , University Union fee , Migration and Cancellation have not been revised/enhanced.

- 2. As per the Govt. order read 3rd above, orders have been issued by Govt. of Kerala for 5% enhancement of the existing fee for services rendered by the Govt. Department/Public Sector undertaking /Grant-in-aid institutions for the year 2019-20 onwards. The matter was placed before the committee constituted by University for revision of fee vide order read 4th above.
- 3. The committee met on 25.07.2019 and their recommendations was placed before the 56th Governing Council meeting held on 26.08.2019 and the Governing Council decided to enhance the prevailing fees for various services rendered by the University by 5% with effect from Academic Year 2020-21. It has been decided to round off the fraction next to 100 related to affiliation and allied fees and round off the fraction next to 10 related to other fees. Since the CCIM has revised the existing slab of student intake from 50 to 100 as 60 to 100 modification in this regard shall also made in the fee structure of Government /Aided under AYUSH Stream.
- 4. Sanction has been accorded by the Hon'ble Vice Chancellor to implement the above said decision of the Governing Council in fixing of fee for affiliation and allied matters from the year 2020-21 onwards, as appended.
