**ORDER**

3. As per the Section 33(2) (iii) to (vi) of the Kerala University of Health Sciences Act 2010, the hon'ble Vice Chancellor has nominated the persons to be included into the Planning Committee. As per the section 33(2) (vii) of the KUHS Act 2010, the Governing Council meeting held on 01.09.2018 vide decision read 2<sup>nd</sup> above has elected Dr. Valsamma Joseph, Principal, Government College of Nursing, Kottayam into the Planning Committee from among the Principals of an affiliated Government College of Health and Allied Sciences, who are the members of Academic Council.
