Order

As per KUHS Course Regulations, 2016 for BSc (Optometry), the Examiner/ Evaluator should possess three -years of Post-PG experience in the concerned subject. But on scrutiny, it was found that the experience mentioned in the declaration submitted at CV Camp by the Evaluators was not matching with the experience shown in the Faculty-list uploaded by the colleges. A situation, thus arose, where there was shortage of eligible Evaluators with experience as insisted by the above Regulations. In this circumstances, the Chairperson of CV Camp had requested to include the Evaluators with Post PG experience of less than three years but not less than one year.

The Dean of Allied Health Sciences has suggested for considering Evaluators from BSc (Optometry), teaching Faculty with more than one year post PG teaching experience for timely completion of the valuation, which was ratified by the Chairman of Board of Studies – Clinical Allied Sciences also, and the evaluation was conducted as per the modified norms.

The 14th meeting of Board of Examinations have considered the matter in detail and ratified the action in appointing Evaluators with less than three years experience for First year BSc Optometry degree Regular/ Supplementary Examination, December-2017. It was further decided to continue this policy of appointing Evaluators with one year Post PG teaching experience for another succeeding three academic years vide paper read as (1) above.

The 45th meeting of Governing Council has approved the decision of the Board of Examinations vide paper read as (2) above.

Vide paper read as (3) above the Hon'ble Vice Chancellor has accorded sanction for implementing the decision on the GC with regard to the appointment of Evaluators with less than three years experience for BSc Optometry course.

It is also hereby ordered that "another succeeding three years", shall be computed from the date of this University Order.

Orders are issued accordingly.
