ORDER

As per the Clause 35, Chapter IV of the Kerala University of Health Sciences Act, 2010, a Research Council has to be constituted consisting of the Vice chancellor, Pro Vice Chancellor, Heads of the University Departments and Directors or eminent scientists from the Research Institute within or outside Kerala. The members of the Research Council shall be nominated by the Vice Chancellor in consultation with the Governing Council. In fulfilment of the above clause, a Research Council had been constituted in the year 2015 under the Chairmanship of the Hon'ble Vice Chancellor vide paper read (1). The term of this Research Council completed on 17.04.2018.

As per paper read as (2), the Research Council was reconstituted by Hon'ble Vice Chancellor, KUHS with the proposed persons on expiry of the term of the Research Council thus constituted vide paper read as (1) above. In the event of retirement of Prof. (Dr.) M K C Nair from the post of Vice Chancellor of Kerala University of Health Sciences and on assumption of Dr. Sabu Thomas as the Vice Chancellor of Mahathma Gandhi University, Kottayam, the reconstitution of the Research Council is necessitated with adequate changes.


