## **Approval of Minutes of various Faculties**

- i) To approve the minutes of various Board of Studies and faculty of Dental Science will be presented by the Dean, Faculty of Dental Science.

The Academic Council approved the minutes of various board of studies and faculties presented by the concerned deans of various faculties with the following suggestions: -

- i. The Dean, Faculty of Dental Science requested to conduct training for the teaching faculty to conduct inspection.
- ii. The Dean, Faculty of Medicine stressed the point regarding the eligibility criteria of MBBS course which was approved. The Dean explained that animal experiments are banned by the Medical Council of India, hence curriculum of subjects; pharmacology and physiology need to be modified excluding the animal experiments including alternatives. The Academic Council entrusted the subcommittee already constituted to submit the report in next Academic Council meeting.
- iii. The decision of Faculty of Pharmaceutical Science to extend the cut-off date of admission of Pharmacy courses to 15.9.2013 is rejected. The previous decision of the 3<sup>rd</sup> meeting of the Academic Council that the candidates who passed in supplementary examination can continue the course with their original batch, but they will have to appear for the University examination along with the supplementary examination of that batch; hence there will be a course lag of 6 months for such candidates "is modified as per clarification received from Pharmacy Council of India vide Lr. No: 14-194/2011-PCI/21492 dated 21/8/2013 that all the failed students even if they fail in more than two subjects will be promoted to the next higher class and if they clear the failed subjects in the supplementary examination they can continue with the original batch and appear for regular examinations of second year. Students who fails in more than two subjects in supplementary examination will continue with the preceding batch".
- iv. The resolution of the Faculty of Nursing that consent of affiliation for new colleges/courses/increase of seats shall be granted only to nursing colleges attached to medical colleges and to institutions having its own 500 bedded hospital with 80% bed occupancy has been approved by the Academic Council.
- v. The Academic Council decided that change in question paper pattern of BCVT and B.Sc Perfusion technology which will be applicable for examinations from 2014 onwards. Moreover, the academic council also deferred the decision no: 10 of BoS Medical Laboratory Technology to permit lateral entry admission to second year B.Sc MLT course for students who completed DMLT course.

# Eligibility of qualifying examination through National Institute of Open Schooling (Partial appearance)

The Academic Council meeting held on 6.3.2013 decided vide decision no: 4.6 to approve qualifying examinations conducted by NIOS which is approved by the respective statutory councils for pursuing U.G. courses under KUHS. Now, students who complete one subject through distance mode and other subjects through regular course at the same time are applying for eligibility. Clarifications are needed whether such candidates are eligible for pursuing U.G. courses under KUHS.

### **Issuance of eligibility certificate**

Statutory councils like Medical council of India and Indian Nursing Council are insisting that English should be taught as a subject in the qualifying examinations. Applications are being received from candidates who completed their qualifying examination from outside India where the language spoken is English (Eg. U.K.). In such cases where English is not a subject of study, clarification is required whether to issue eligibility certificate.

The Academic Council decided not to issue eligibility certificate for candidates who have not studied English as a subject for their qualifying examination.

As per the decision of the Governing Council a three member committee with Dr. K. Mohanan, Prof & HOD of Radiodiagnosis as Chairman and Smt. Valsamma Joseph, Principal, Govt. College of Nursing, Thrissur and Dr. Thomas Manjooran, Dean, Faculty of Dental Sciences as members and the committee met on 30.7.2013.

# Fee for legal scrutiny of land documents pertaining to affiliation of new college

For granting of affiliation for colleges/course, the documents of ownership of property in which the institution is situated, its extent and other details, consolidated balance sheets, fee etc are to be scrutinized. In order to verify these documents legal expertise is required. After considering the matter in detail, the Vice-Chancellor has accorded sanction vide U.O. No: 1074/Ac.B/KUHS/2012, Dated 27/9 /2013 for appointing a panel of Law officers and to fix remuneration for the verification of the documents as Rs. 2500/- per document subject to a maximum of Rs. 10,000/- for verification of all documents pertaining to an institution subject to ratification of the Academic Council.

## <u>Fixing of revised fee for affiliation and allied matters related to super speciality courses</u>

The University has fixed the fee to be remitted by colleges for affiliation and allied matters of various courses for the Academic year 2013 onwards.

A representation has been submitted by Medical College Management Association to review the fee fixed by the university with respect to Medical super Speciality courses. The Medical College Management. A meeting was held with Pro Vice-Chancellor regarding this matter and the Medical College Management Association has decided to withdraw the petition filed by them in this matter in the Hon'ble High Court of Kerala. Accordingly the Vice-Chancellor has accorded sanction vide U.O. No: 5285/AC/KUHS/2011 dated 7/09/2013 to revise the fee fixed for affiliation and allied matters of Medical Super speciality courses subject to ratification of the Academic Council.

### **Fixing of Fee of Re-inspection**

It has been observed that the university is conducting re-inspection for various purposes such as starting new colleges, courses and granting of continuation of provisional affiliation. For the above purpose university is not collecting any fee other than the inspection fee collected at the time of submission of applications. But for the inspectors who conduct subsequent inspection university has to pay TA/DA and inspection fee. It results in financial loss to the University for conducting re-inspection/subsequent inspection in the affiliated colleges for various purposes and after considering the matter in detail the Vice Chancellor has accorded sanction for fixing a sum of Rs. 10,000/- from the college as re inspection/subsequent inspection fee vide U.O. No: 5285/AC.B/ Fee /Re inspection/KUHS /2013 dated 23/08/2013 subject to ratification of the Academic Council.

## **Change in Regulation of B.Pharm (Ayurveda)**

The present regulations of B.Pharm (Ayurveda) were modified as per decision of Faculty of Ayurveda which was approved by the Vice Chancellor subject to ratification of the Academic Council as follows:

*Eligibility for appearing for University Examination:*- There should be 80% attendance in all subjects (theory and practical separately) and a candidate must obtain 35% of marks in internal assessment in all subjects to be eligible to write the university examination. The class average of internal assessment marks should not exceed 75%.

*Criteria for Pass:*- A candidate should secure 50% aggregate marks in each subject with practical (theory + IA & Practical + Viva + IA) and in each subject without practical (theory + Viva + IA) and 45% in University theory and University practical (Practical + viva + IA) separately. Moreover, 50% aggregate marks in theory (theory + IA) and practical (practical + viva voce + IA) should be obtained.

*Grace Marks:*- Maximum 5 marks can be given to a subject or may be distributed among different subjects for a whole pass or a subject pass (theory / Practical) as per the discretion of the pass board. No grace marks will be given for internal assessment.

**Promotion:-** The candidates who are eligible to appear for University Examination are eligible for promotion.

## **MODIFICATION**

*Eligibility for appearing for University Examination:*- There should be 80% attendance in all subjects (theory and practical separately) and a candidate must obtain 35% of marks in internal assessment in all subjects to be eligible to write the university examination. The class average of internal assessment marks should not exceed 75%.

*Criteria for Pass:*- A candidate should secure 50% aggregate marks in each subject with practical (theory + Practical + Viva) and in each subject without practical (theory + Viva) and 45% in University theory and University practical (Practical + viva) separately. Moreover, 50% aggregate marks in theory (theory) and practical (practical + viva voce) should be obtained.

*Grace Marks:*- Maximum 5 marks can be given to a subject or shall be distributed among different subjects for a whole pass or a subject pass (theory / Practical) as per the discretion of the pass board. No grace marks will be given for internal assessment.

**Promotion:-** The candidates who are eligible to appear for University Examination are eligible for promotion.

Internal Assessment is considered only for eligibility criteria to write exam.

# <u>Change in Class Average of Internal Assessment marks for P.G. Pharmacy courses</u>

The Board of Examinations dated 14/11/2012 vide decision 6 –b resolved to remove the ceiling of class average of internal assessment marks for M.Pharm course from 2013 examinations. This decision was implemented for M.Pharm Examinations conducted during February 2013 and September 2013.

#### Distribution of marks for internal assessment

Application based on RTI are received regarding submission of number of assignments for internal assessment. Moreover, the regulations of various courses does not clearly specify the distribution of marks for various aspects (Assignments, Project work, seminar etc.,) of internal assessment. Hence, norms are to be fixed clearly specifying the mark distribution for internal assessment and the number of assignments, project work etc.

The Academic Council decided that the institutions shall prescribe the distribution of marks for internal assessment

## **Class average of the Supplementary Candidates**

The general regulation of the University insists that the class average of internal assessment marks should not exceed 75%. But in supplementary examinations, since the number of students appearing for the examinations is limited there is chance for increase of class average.

The Academic Council decided to change the regulation that the class average for internal assessment marks of supplementary examinations shall not exceed 80% instead of 75%. The class average of internal assessment marks will remain 75% for the Regular examinations. This will be effective from 2014 examinations onwards.

#### Minimum Attendance criteria for P.G. Students

As per the present regulation, 80% attendance in a year is mandatory for medical P.G. students. It is to be clarified whether yearly 80% attendance or aggregate 80% attendance is mandatory for P.G courses where the examinations are conducted only in the final year.

The Academic Council decided that 80% of attendance per year is mandatory for all P.G. courses where examinations are conducted only in final year.

## <u>Issuance of mark list for P.G. degree/Diploma and Super speciality courses</u>

Now, the University is not issuing mark list for P.G. degree/Diploma and super speciality courses of all streams. Requests from students are received for issuance of mark list for these courses as they are not aware whether they have failed in theory, practical or viva voce.

The Academic Council decided to issue mark list for P.G. degree/Diploma/ Super Speciality courses of all streams on request stating the reason and entrust the University to fix the fee for mark list

### **Condonation of Attendance**

- i) As per general regulations of the University, the students are eligible for condonation of attendance up to a maximum of 10% in a subject or subjects once during the entire course. The Principal/Head of the Institution of the colleges are entrusted with the power of granting of condonation on recommendation of the Head of Department/Department in charges, under intimation to the Controller of Examinations. Regulations of some courses insisted on forming a committee for granting condonation. A general norm is to be formulated for maintaining uniformity for granting condonation. Moreover, clarification is needed whether any fee is to be levied for granting the same.
- ii) Steps for ensuring the granting of condonation is only once in the entire course for a candidate is also to be decided.

The Academic Council decided not to grant condonation of attendance for P.G. courses and fixed the fee for condonation of U. G. courses as Rs. 500/which is to be remitted to the University account along with the exam registration details from 2014 onwards. The meeting also decided that a register should be maintained by the colleges for ensuring that condonation is granted only once during the course and also resolved that the Examination section of the University should take measures for noting down the details of students who had been granted condonation.

Answer books received from the examination centres are verified, shuffled and coded and sent to the <u>different Practical Examination Centres</u> for evaluation.

# ii) MDS Part 1, MD (Ayurveda) Part I, MD(Hom) Part I, M.Pharm, Pharm D, M. Sc. Nursing, MPT, MASLP, M. Sc. Medical Physiology, MHA and M.Sc. MLT

Answer books received from the examination centres are verified, shuffled and coded and valued in the <u>Centralized Valuation Camps at KUHS</u> <u>Campus</u>

#### **Medical Super Specialty**

Answer books of Super Specialty Examinations received from the examination centres are shuffled and coded and sent to the <u>same Examination</u> <u>Centres</u> where Practical Examinations are conducted for evaluation.

## C) Number of Valuation

If the difference between the two marks are more than 15% of the total marks, there is a third valuation and the average of the nearest two marks are taken as the final mark. No revaluation is permitted. Only retotaling is permitted.

## i) Medical PG Degree/Diploma, Medical Super Specialty, MDS Part II, MD (Ayurveda) Part II and MD (Hom) Part II Examinations

Answer books are valued four <u>times</u> i.e. by the internal examiners and the external examiners and the average of four marks is taken as the final mark. No revaluation is permitted. Only retotaling is permitted.

# ii) MDS Part I, MD(Ayurveda) Part I, MD(Hom) Part I, M.Pharm, Pharm D, M.Sc. Nursing, MPT, MASLP, M.Sc. Medical Physiology, MHA and M.Sc. MLT

Answer books are valued <u>two times</u> and if the difference between the two marks are more than 15% of the total marks, there is a third valuation and the average of the nearest two marks are taken as the final mark. No revaluation is permitted. Only retotaling is permitted.

## D) Valuation by Chairperson

In the case of Medical PG Degree/Diploma, Medical Super Specialty, MDS Part 1I, MD Ayurveda Part II and MD (Hom) Part II, the Evaluation Chairperson is also one of the four evaluators.

Normally, the Evaluation Chairpersons do not value the answer books. However in certain circumstances where the number answer books are very less and the evaluators are not available on the particular dates of the CV Camp, the Evaluation Chairpersons are permitted to evaluate answer books as a special case.

## E) Issue of the Photocopy of the Answer Books

Photocopy of Answer Books are being issued to those candidates who apply for the same with a fee of Rs.500/- per answer book. Score sheets are not provided with the photocopy of answer books. Unlike answer books of other Universities in Kerala, there are four score sheets attached with each answer books of this University and these score sheets are detached after entering the marks and keep in separate packets. More over evaluators are putting their signature with name in each score sheet. Hence it is very difficult to take xerox

copies of each detached score sheet of each answer book by concealing the signature and name of each evaluator.

Hence, it is suggested that re totalling/scrutiny of score sheets may also be done in the cases of the answer books for which applications are received for photocopy with or without insisting additional fee.

The Academic Council reviewed the examination procedure and decided to continue the same with the changes noted below.

*i)* The maximum number of answer scripts to be evaluate per day for U.G. courses

Papers with 2 hours and above – upto 45 Less than 2 hours - upto 60

For P.G. courses - upto 20 per day

- ii) Evaluation of theory papers in respect of Medical Super speciality examinations at the same centre where practical is also conducted for the same students will continue only upto 2015. From 2016 onwards, barcoded answer books will be sent to different evaluation centres where practical examinations are conducted, after shuffling
- iii) Photocopy of answer books may be issued to the candidates on their request only after conducting a re-totalling of marks, without insisting additional fee

#### **Appointment of Observer for the conduct of theory examinations**

Inter disciplinary observers from all faculties are appointed in theory examination centers in order to ensure that the examinations are conducted in a fair manner. Since, the CCTV installations are made mandatory in all examination centers from 2013 examinations onwards, appointment of observers may be made on random basis for all theory centers.

## **Registration of First year Examination**

As per the present regulation, all students should register compulsorily for the first year examination, even though they are ineligible to appear for examination. Now, partial appearance is permitted for all the university examinations as per decision no: 3.19 of the academic council meeting dated 15/11/2012. This rule may be modified as only eligible candidates should register for all the examinations including first year and the exam registration shall be done only for the papers he/she is appearing.

### **Ratification of Mercy chances for M.Sc Nursing**

As per the University Regulation of M.Sc Nursing course, there are only 3 chances to appear for the first & second year examination of M.Sc Nursing course. The candidate has to pass  $I^{\rm st}$  Year M.Sc Nursing Examination to appear for the  $II^{\rm nd}$  Year M.Sc Nursing Examination. Out of 364 students(2010 admission) registered for the Oct 2011 examination 249 students only passed and out of 115 students remaining , 87 students passed in the supplementary examination in June 2012. 13 students passed in the regular examination Oct 2012.

On request of three students, and on recommendations of the Dean, Faculty of Nursing, the Vice Chancellor had granted a mercy chance to the students to appear in the supplementary examination held in June 2013. Again, as per the request of the students of Reg.No.103520019 and 103510025 to grant one more mercy chance, the Vice Chancellor had given a fifth and the last chance for these students to appear for the Regular/Supplementary examination to be held in September 2013.

### **Partial Appearance for University Examination**

Now, requests are received from students to grant permission for appearing in university examination for those subjects in which they have minimum required attendance. - (a)who secured more than 60% or above, in other subjects.

Dr. Praveenlal Kuttichira, Dean, Research stated that the granting of affiliation to new colleges/courses may be considered only after the report of the committee for preparing perspective plan for the University is received.

The Academic Council decided to place the matter before the Governing Council for decision.

iv) Review of cut off dates for enrolment of students

It is decided that online registration of students admitted for various courses under KUHS will be permitted up to midnight of the last date prescribed by the Govt/Statutory council/KUHS. In any case if the college fails to complete the registration within the stipulated time the colleges can submit the details directly to the University office upto 5'0' Clock in the succeeding working day.

v) Non participation of the faculty members in the examination and evaluation of theory papers

The Controller of Examinations put forward the item and a detailed discussion is held. The Academic Council members expressed their views regarding the matter and suggested even the withholding of examination results of colleges from which the faculty members relinquished the examinership/evaluation duty. Since, this may be at the cost and risk of the students, it is suggested that a huge penalty may be levied from such colleges and may take measures for withdrawing the examination centre and also even continuation of affiliation.

Dr. K.B. Sudhikumar, Dean, Student Affairs proposed a vote of thanks.
