Order

Cases of suspected malpractice in MDS part-I and Part-II examination July 2015 at Azeezia Dental College, Kollam was reported to the university and the same was considered by the Malpractice and Lapses Enquiry Committee, vide paper read as (1) above. The MLEC has summoned the concerned chief superintendents of Azeezia Dental College, Kollam for a hearing and has identified serious lapses and negligence in the conduct of examination made by this college. The MLEC has unanimously recommended to de-recognize the examination centre for MDS examinations for two years.

The meeting decided to **withdraw the examination centre status (both Theory & Practical) at Azeezia Dental College, Kollam, for the ensuing MDS Part-I & Part-II Examinations. Further it was also decided to impose fine @ Rs.25000/- (Rupees Twenty Five thousand only) per speciality in addition to the actual expenses incurred to conduct the said examinations in another centre/ centres. The ensuing Theory and Practical examinations for MDS Part-I & Part-II will be conducted at a different centre as directed by the Controller of Examinations and the actual expenses will be released to the centre/ centres where these examinations are conducted.**

The meeting also discussed the case of Dr.Janaki Krishnan.T.S, Lecturer, DPM Homoeo Medical College, Eranakulam who attended the First year BHMS Degree Examinations (Supplementary) August 2015 valuation camp for Anatomy Paper II and caused certain hardships to the University. She was found to have behaved irresponsibly with regard to the rectification of an error in the answer book which has to be submitted to the Board of Adjudication of Student Grievances.

The meeting observed that the behaviour of the evaluator was quite unbecoming and action need be taken against her. The meeting decided to debar Dr.Janaki Krishnan.T.S, Lecturer, DPM Homoeo Medical College, Eranakulam from Examinership(Centralized/External & Evaluation) for one year and to publish the matter in the University website.
