ORDER

As per the notification read 1st above, the University had invited application from various Medical, Dental, Ayurveda, Homeopathy. Sidha, Unani, Nursing, Pharmacy and Paramedical institutions affiliated to the University for continuation of provisional affiliation of the colleges/courses during the academic year 2018-19 and the last date for submitting the online application falls in 13.10.2017, In spite of repeated reminders some of the affiliated colleges failed to submit the application in time.

The colleges, who failed to submit online application in time and the colleges were granted Provisional affiliation for the year 2017-18 after the last date fixed for submitting online application have requested to open online facility for submitting the application.

The matter was placed before the Governing Council for consideration and the 43rd Governing Council meeting held on 29.12.2017 vide decision read 2nd above, has decided to provide online facility to those colleges who failed to submit application for continuation of provisional affiliation inspite of reminders for the year 2018-19 in time by imposing fine Rs. 1 lakh (Rupees one lakh only). The Governing Council has also decided to provide online facility to upload the application to those colleges who failed to submit application for continuation of provisional affiliation for the year 2018-19 due to technical issues on the part of the University and to colleges /courses who were granted provisional affiliation after the last date for uploading the application without fine.

Sanction has been accorded by the Hon'ble Vice Chancellor to implement the decision of Governing Council (item No.43.07) and orders are issued accordingly.

Medical College, Kozhikode and Mrs. Rajasree.R.S, Associate Professor, College of Pharmaceutical Sciences, Govt. Medical College, Alappuzha as Chairpersons of Board of Studies Pharmacy PG and UG respectively on vacancies arising on account of resignation of then Dean and Chairpersons PG and UG .

The Faculty shall have the powers and functions as prescribed in Chapter IV Clause 31 of the Kerala University of Health Sciences Act 2010. The Chairperson of UG and PG Board of Studies Pharmacy shall have the powers and functions prescribed in the Section 29 of KUHS Act 2010.

The term of appointment of Dean, Faculty of Pharmaceutical Sciences shall be from the date of issuance of this order to **17.06.2018** and the Chairpersons of Board of Studies Pharmacy PG and **UG** shall be from the date of issuance of this order to **11.05.2018**.

KUHS- Academic- Granting of Affiliation after commencement of Academic year and approval of Student Registration -norms fixed – Governing Council decision -implemented- Orders issued.

ORDER

As per the Chapter XXI Statutes 10 (3) of the first Statute of the Kerala University of Health Sciences, unless all the conditions are fulfilled, before the commencement of the academic year, no new college/or additional courses/or enhancement of seats shall be permitted to be started during that year.

In compliance of the orders from the Hon'ble High Court of Kerala and issuance of Letter of Permission from Central Council and Ministry of Govt. of India for starting new college/course/enhancement of seats after the commencement of said academic year, the University is bound to grant affiliation after the commencement of academic year. As such the students admitted are not able to complete their attendance requirements before exam registration. This creates various other academic issues including jeopardization of the merit of admission.

The matter was placed before the Governing Council for consideration and the 43rd Governing Council meeting held on 29.12.2017 has decided to strictly adhere to the provisions of Chapter xxi Statute 10 (3) of the first statute with regard to granting provisional affiliation for courses/colleges/enhancement of seats after the starting of academic year. The Governing Council has also framed following norms for granting affiliation to the colleges under Kerala University of Health Sciences:-

1. Unless all the conditions are fulfilled before the commencement of the academic year, no new college/additional courses/enhancement of seats shall be permitted to be started during that year. The commencement of the academic year for each stream shall be fixed by the Academic Council.

2. In the case, where LOP from apex council was received on a later date after the commencement of the academic year for that particular course and in order to curtail the difficulties, both technical and operational, affiliation may be granted on the condition that admission of students shall be permitted from next academic year onwards only.
3. To ensure transparency in admission and fair fee structure in the affiliated colleges and exercising the powers of the Governing Council as stipulated under section 23 (vi), it was decided that all admissions made for any course shall be with the approval of the competent authority as decided by Government/University or with the approval of Admission and Fee Regulatory committee for Medical Education in Kerala appointed by Govt. of Kerala.

Sanction has been accorded by the Hon'ble Vice Chancellor to implement the decision of Governing Council (item No.43.06) and orders are issued accordingly.




